



## BOOKING CONDITIONS

- 1 All participants must be 18 years or older. Children between the ages of 8 and 18 may participate provided that they are supervised by their parent or legal guardian, or alternatively any adult who has been authorized in writing by the attending child's parent or legal guardian, to supervise the attending child.
- 2 The attending child's birth certificate must be presented before participation at the HealthyFood Studio will be permitted.
3. A child to adult supervision ratio of 1:1 will apply to children under 14 and a ratio of 2:1 will apply when children over 14 are participating in a class.
4. Full payment and a completed application form will be required in order to secure your space. This will be arranged on a first come first serve basis.
5. Recipes are subject to change depending on the availability of ingredients.
6. For a course to be conducted a minimum of 8 participants will be required. Should we not meet the minimum number required, Discovery Vitality (Pty) Ltd ("Vitality") reserves the right to cancel the class and shall notify clients of the cancellation no later than 48 (forty eight) hours prior to the scheduled commencement of selected class. Clients may elect to either reschedule to an alternate date or request a refund.
7. **Cancellation policy**
  - 7.1. The client will be entitled to cancel the booking at any time, and will be entitled to either reschedule to an alternate date, or may elect for someone else attend in their place on the originally scheduled date. Should the client not prefer the above, the client may

request a refund, provided that such cancellation is communicated no later than 48 hours prior to the scheduled commencement of the booked class.

7.2. **KINDLY NOTE: In the event of a class being booked within 48 hours of commencement, the refund policy will not apply. The client is urged to bear same in mind when booking.**

8. It is in the interest of hygiene and safety you are advised to wear appropriate clothing including low heeled covered shoes in the kitchen, hair tied back and minimal jewellery as well as the HealthyFood Studio apparel provided to you.

9. INDEMNITY

9.1. We make every attempt to identify ingredients that may cause allergic reactions for those with food allergies. Every effort is made to instruct our staff on the severity of food allergies. In addition, we label items with possible allergen-containing ingredients; however, we cannot guarantee the absence of cross-contamination of ingredients. There is also a possibility that manufacturers of the commercial foods we use could change the formulation at any time, without notice. Participants concerned with food allergies need to be aware of this risk. You are required to advise us of such allergens and/or dietary requirements as it may pertain to you and/or the attending child prior to participation at the HealthyFood Studio.

9.2. By signing the indemnity form, you indemnify the HealthyFood Studio, Vitality and Discovery Ltd against any loss, damage, injury or death you, the attending child or your beneficiaries may suffer as a result of participation in the HealthyFood Studio class. By agreeing to these rules you, your beneficiaries and any third parties indemnify the HealthyFood Studio, Vitality and Discovery Ltd accordingly.

9.2.1. The parent or legal guardian of a participant between the age of 8 and 18 will be required to complete an indemnity and consent form on behalf of their child.
